#### In Attendance

### FROM NOTICE OF MEETING

## CHAIRMAN JOY OPENED THE MEETING

5:45 p.m. BOS Chair Christine Joy opened the meeting. Seconded by MR. Roll call vote 3-0.

## **UPDATES & DISCUSSIONS**

Members of the Wage & Personnel Board, along with the Finance Committee members discussed the proposed Cost of Living Adjustment (COLA) recommendation for Fiscal 2023. Wage & Personnel will be meeting on 12/14/2021 to finalize the vote of the COLA for FY2023.

Town Administrator Liz Dennehy requests the BOS vote on formally adopting the 2021 Plympton Hazard Mitigation Plan. CJ made a motion to adopt the 2021 Hazard Mitigation Plan for Plympton. Seconded MR. Roll call vote 3-0.

The BOS discussed the parcel of land off Old Brook Street. The land may be potentially used for Habitat for Humanity Affordable Housing opportunity. The BOS would like the land to be appraised for a value to be established before the town would proceed with any action. JT made a motion to have LD get three appraisals

and authorize her to proceed with the lowest price appraisal service. Seconded CJ. MR was opposed. Roll call vote 2/1.

## 6:30 p.m. Transfer Station:

Art Morin updated the BOS on the 12-month survey of household use of stickers and cost to the town. Currently the town has 341 regular full priced stickers, 275 Senior priced stickers, and 204 second priced stickers. To bridge the gap, they are requesting the BOS vote to raise the cost of stickers. Regular from \$200 to \$240, and Seniors from \$100 to \$120. All other sticker prices will remain as is. CJ made a motion to approve the price increase on regular and senior transfer stickers. Seconded MR. Roll call vote 3-0.

The Selectmen finalized the Employment Agreement with Police Sergeant Matt Ahl in Executive Session. CJ made a motion to execute the Agreement between the Town and Matt Ahl. Seconded MR. Roll Call Vote: 3/0.
