FROM NOTICE OF MEETING



CHAIRMAN JOY OPENED THE MEETING

5:45 p.m. BOS Chair Christine Joy opened the meeting in Open Session, as required under the Open Meeting Law and will continue with Town Meeting. Seconded MR. **Roll call vote 3-0.**

UPDATES & DISCUSSION:

- Zak Farkes from Borrego Solar and Jonathan Eichman, Town Counsel joined the meeting to discuss the amendment to the Settlement and Agreement for Judgment.
 - Some specifics from Borrego are in the diagram below.



Conservation Restriction Area 1 (CR1): +/- 37.5 acres

Conservation Restriction Area 2 (CR2): +/- 21.5 acres

Solar Area and Access Easement (PV): +/- 16.5 acres

Remaining Land (RL): +/- 115 acres

CJ made a motion to approve and endorse in the form submitted an amendment to an Agreement for Judgment dated September 26, 2002, and a Settlement Agreement fully executed February 11, 2017, concerning property on Upland Road presently owned by Crescent Moon Cranberry, LLC, for the purpose of allowing the installation of a commercial solar energy facility on a certain portion of the 225 acres of land restricted from development by paragraph 8 of the Agreement for Judgment, and as consideration therefor to place 202 acres of that land under a recorded restriction preserving its use in perpetuity for agricultural, conservation and/or passive recreation purposes and the Town will consider entering a PILOT agreement with Borrego on said solar facility. Second MR. **Roll call vote 3-0.**

- TA updated the BOS on the North Carver Redevelopment Project. Plympton will have an officer parking at the entrance of Montello Street during the day shift for part of the time, Carver PD will also help in making sure no trucks will be accessing the roadway from the Plympton side. Carver and Plympton Highway Departments will be in discussions to help resolving the truck issues. CJ will be attending two upcoming meetings with the RDA.
- The BOS received a letter from the Town of Hanson regarding a Regionalization Opportunity with the town. Jason Fraser gave his insight on the matter, but not as representative of the Plympton School Committee or the Silver Lake Regional School Committee. CJ and MR will attend the July 26 meeting with the Silver Lake School Committee.
- Jason Fraser discussed the Special Education Reserve Fund that was established with the help of Town Meeting and the BOS. Mr. Fraser presented the idea to establishing a Revolving Fund for Regional Assessments which would be controlled by the municipal side.
- TA is working with Jon Wilhelmsen and presented a spreadsheet to the BOS with potential uses and projects for the spending of the American Rescue Plan Act (ARPA) funds being given to the Town from the County. The Town is expected to receive \$562,788. Plympton has already received \$140,000. and is also expected to receive an additional \$312,000 in local ARPA money.

- CJ made a motion to appoint Timothy Johnson as a Part-time Police Officer through June 30, 2023. Second MR. **Roll call vote 3-0.**
