October 17, 2022

IN ATTENDANCE

Selectmen Christine Joy, John Traynor (JT) and Mark Russo (MR), Town Administrator Liz Dennehy (TA), and Briggette Martins (SA).

CHAIRMAN CHRISITINE JOY OPENED THE MEETING

5:45p.m. BOS Chair Christine Joy opened the meeting in Open Session, as required under the Open Meeting Law and made motion to enter Executive Session under M.G.L. c.30A, §21(a) Purpose 3, CJ declared that BOS would return to Open Session after the adjournment of Executive Session. **Roll call vote 3-0.**

Department Update

CJ introduced the Building Inspector Tom Millias to the meeting to give an update of the inspectional services, enforcement, and permits that have been completed and are still in progress. Tom introduced his assistant Kathy Canizzo. Tom and Kathy are also the Zoning Officers for the Town. Kathy spoke on their behalf. The BOS thanked them for all the hard work and progress they have made.

Special Town Meeting Board of Selectmen Sponsored Articles

TA read each of the 7 Articles that will be presented at the Special Town Meeting. These Articles are sponsored by the BOS for the Special Town Meeting scheduled for November 30, 2022. CJ made a motion to approve BOS sponsored Articles for the Special Town Meeting on 11/30/2022. Seconded MR. **Roll call vote: 3-0.**

2022 State Election Warrant

CJ made a motion to approve the Warrant for the November 8, 2022 State Election. Seconded MR. **Roll call vote: 3-0.**

Land Gifted

The Town has been gifted two pieces of land for the sum of \$1.00 each. One parcel gifted by Robert Sarofeen located off Prospect Road approximately 1.5 acres in size, known as “lot of fresh meadow on Whetstone Vineyard Brook”. The other parcel gifted by Curtis Shaw located off Prospect Road, known as the “Sampson Fresh Meadow”. Both parcels are adjacent to Two Brooks Preserve. A vote of the Selectmen is required to authorize the Conservation Commission’s vote to accept said parcels.

CJ made a motion to authorize the Conservation Commission to accept both land gifts. Seconded MR. **Roll call vote: 3-0.**
