5:45p.m. BOS Chair Christine Joy opened the meeting in Open Session, as required under the Open Meeting Law and made motion to enter Executive Session under M.G.L. c.30A, §21(a) Purpose 3, CJ declared that BOS would return to Open Session after the adjournment of Executive Session. **Roll call vote 3-0.**

Updates & Discussions

Dennett Solar Power Purchase Agreement and Lease

TA shared the motion provided by Town Counsel. CJ read the motion. Seconded, MR. Roll call vote: 3-0.

Whereas Town Meeting has voted on May 12, 2021 and on May 18, 2022 to authorize the Town to join PowerOptions and to negotiate and execute the necessary documentation to allow the development, installation, and maintenance of a solar facility on a portion of the Dennett Elementary School Rooftop, and whereas the School Committee of the Town of Plympton has voted to surplus a portion of the Dennett Elementary Rooftop and transfer it to the control of the Town, now therefore, the Board of Selectmen votes to accept control of said portion of the Dennett Elementary School Rooftop, and

hereby approves the Lease and the Power Purchase Agreement presented to it at this duly called meeting, and further hereby authorizes the Chairman to execute the Lease and Power Purchase Agreement in the form presented at this duly called meeting, and any other documents necessary to effectuate this vote as recommended by the Town Administrator and Special Counsel.

Turkey Swamp

MR requested the BOS vote for him to accept the Purchase & Sale for the purchase of Turkey Swamp. CJ made the motion to authorize MR to accept the documents. Seconded, JT. **Roll call vote: 3-0.**

2023 Annual & Special Town Meeting

CJ made a motion to open the warrants for the Annual and Special Town Meeting for 2023. Seconded, MR. **Roll call vote: 3-0.**

2023 Election Calendar and Ballot

The Town Clerk requested the BOS vote to accept the election Calendar and Ballot for the 2023 Annual Town Election.

CJ made a motion to accept the election Calendar and Ballot for the 2023 Annual and Special Town Meeting. Seconded, MR. **Roll call vote: 3-0.**

The Town Clerk also discussed early voting and voting by mail process. A vote from the BOS is required to Opt-in or Opt-out. The discussion will continue at the next scheduled meeting on 2/27/2023. The Clerk will forward more information to the BOS.
