### IN ATTENDANCE

## CHAIRMAN CHRISTINE JOY OPENED THE MEETING

5:45p.m. BOS Chair Christine Joy opened the meeting in Open Session, as required under the Open Meeting Law and made motion to enter Executive Session under M.G.L. c.30A, §21(a) Purpose 3, CJ declared that BOS would return to Open Session after the adjournment of Executive Session. **Roll call vote 3-0.** 

# **Updates & Discussions**

Town Clerk Patricia Detterman joined the meeting and updated the BOS of the new election laws and the Opt-in/Opt-out procedures for local elections. The Town Clerk is requesting the BOS vote to approve the vote by mail option. CJ made a motion to Opt-in for the local annual town meeting for 2023. Seconded MR. **Roll call vote: 3-0.** 

# **Forever Stamp**

TA has submitted a letter to the Citizens' Stamp Advisory Committee in Washington, DC, on behalf of the BOS, in support of a Forever Stamp in honor of Deborah Sampson. The original request for the stamp was made by the Town of Sharon, where Deborah Sampson and her husband Benjamin Garnett lived and are now buried. JT encouraged residents to submit a letter in support of the stamp. # **Remote Meeting Provisions**

The BOS discussed the return of in-person meetings. The law that was passed during the COVID-19 pandemic to allow meetings remotely expires on March 31, 2023. There is a bill filed with the state legislature to extend the remote meetings for an additional two years. This would give the option to meet remotely via ZOOM. Each of the BOS have their views on the matter. The zoom meetings have had better public participation than the in-person meetings. The BOS will return to in-person meetings and will re-visit the remote option when the legislation votes. CJ made a motion to return to in-person meetings effective March 27, 2023. Seconded JT. **Roll call vote: 3-0.** 

## **Animal Control**

TA updated the BOS that the Town of Plympton will be discontinuing on the regionalization of the Animal Control services with the Town of Carver due to their inability to provide ACO services as a result of staffing issues. CJ made a motion to discontinue Animal Control services between Plympton and Carver immediately. Seconded MR. **Roll call vote: 3-0.**
