November 27, 2023 Town of Plympton

IN ATTENDANCE

CHAIRMAN CHRISTINE JOY OPENED THE MEETING

Updates & Discussions

Fire Chief Cheryl Duddy joined the meeting to update the BOS of the recent promotions within the Fire Department. The Chief acknowledged the promotions of Andrew Norton to Captain, John Gonsalves to Lieutenant, and William Austin to Full-Time Paramedic/Firefighter.

Town Properties Committee

Jon Wilhelmsen, Chair of the Town Properties Committee updated the BOS on the three potential sites for the placement of a new well. The plan has been submitted to DEP for permitting. He is continuing to work with the consultant on the plan.

New Leaf Energy

Jared Connell, the representative from New Leaf Energy, is requesting the Town extend the timeline of the conservation restrictions for the Upland Road Solar (Assessor's Parcel 13-2-29D). The Amended Agreement for Judgement requires the Owner to grant to Town (or charitable corporation / trust approved by the town) a permanent restriction for the property area known as the "Cranberry Property." The Agreement calls for the restriction to be in place by the end of construction, but allows the Parties to agree on a different date if approved by the vote of the BOS. Construction is nearing completion and is expected to be done in the next couple of months. There has been ongoing discussion about whether the Town (or the Wildlands Land Trust) would take the Conservation Restriction. The BOS recently voted to recommend or establish a preference for Wildlands Trust to hold and mange the restrictions. It would be beneficial to the Town to utilize the language in the agreement allowing the parties to agree on a different date. CJ made a motion

to extend the Conservation Restriction to June 30, 2024. Seconded JT. MR recused from the vote. **Vote: 2-0-1 Recused**
