		all concerns. Planning for no disruption to the neighborhood.
		Plympton Health Agent wants to make sure that
		no airborne dust or asbestos goes down wind towards any of the
		abutters and to make sure that all the abutters are notified
		and they all have their windows closed and they all know what's
		going on. Chief Silva states that prior to this, the DEP
		requires that an asbestos inspection be done by a licensed
		technician. If asbestos is found, the Fire Department will not
		go forward with burning the building. The Fire Chief will
		contact Plympton Conservation Commission regarding installation
		of hay bales or a silt fence if required. There is no propane on
		the site, the electricity is off and the owner will have Eversource
		remove the line going from the house to the street. The Health
