5:45p.m. BOS Vice-Chair John Traynor opened the meeting in Open Session, as required under the Open Meeting Law and made motion to enter Executive Session under M.G.L. c.30A, §21(a) Purpose 2 and Purpose 6. JT declared that BOS would return to Open Session after the adjournment of Executive Session. **Roll call vote 2-0.**

6:00 Public Hearing

Selectmen Traynor reported that the hearing notice was published in the Plympton-Halifax Express. JT read the hearing notice verbatim.

- Public Hearing regarding an application from Cornerstone Energy Services for new transmission lines that will cross above the following public ways: Spring Street approximately 2,000 feet northwesterly of its intersection with Route 44 and Brook Street approximately 1,200 feet northeasterly of its intersection with Old Farm Road.
 - Selectmen Traynor opened the hearing for testimony in favor and in opposition. Representatives from Cornerstone Energy and Eversource

joined the meeting. They addressed selectmen concerns. There were no members of the public in the meeting or any opposition to the project.
