### CHAIRMAN CHRISTINE JOY OPENED THE MEETING

### **Board of Assessors Annual Tax Classification Hearing**

Selectman Chair CJ read the posted and advertised hearing notice to open the Tax Classification Hearing. Joselyn Anderson, Dean Jafferian, and Holly Merry represented the Board of Assessors office to explain the Tax Classification process and make recommendations to the Selectmen.

The purpose of the public hearing is to consider the percentages of the FY2024 tax levy to be borne by each class of taxable real and personal property. The public hearing requires a vote by the Board of Selectmen for the allocation of property tax classification. The Board of Assessors is recommending to not split the rate and for the Board of Selectmen adopt:

• Residential Factor - Motion to adopt the residential factor of 1.00. CJ made motion to Reaffirm the Residential Factor of 1.00, and to vote no on the following exemptions - Residential Exemption, Open Space Discount, Small Commercial Exemption as recommended by Board of Assessors, thereby closing the hearing. Seconded MR. Vote: 3/0.

Land Donation – MR made a motion the Board of Selectmen (BOS) agrees to the donation by Amanda Monti of the land described in the Turkey Swamp Purchase and Sale Agreement as Parcel 3, to the Conservation Commission for conservation purposes in perpetuity. The BOS votes to empower Selectman Mark Russo to

execute all documents related to accepting the donation needed from the BOS.
