 - Real Estate & Personal Property Abatements – deadline is approaching in a few days (Feb 1st) and we currently have 8 RE abatements (mostly Colonials) and a few regulars who apply each year. The FY18 valuation is based on 2016 sales – base rates (per square foot) increased on Colonials, Capes, Raised Ranches. No increase on land values.
 - FY19 Form of List applications for Personal Property tax were mailed to businesses and due back March 1, 2018
 - Exemption applications on Real Estate for seniors, Veterans, CPA, etc. are due April 1, 2018.
 - Chapter Rollback – The Assessors have been asked to prepare a Rollback tax on the Atwood property (75 acres) by the realtor Rick Leo in behalf of the sellers.
 - Owners Unknown Research – Al Vautrinot continues to volunteer his time on Thursdays and assist with researching parcels that are owner unknown.
