TOWN OF PLYMPTON NOTICE OF TAX CLASSIFICATION HEARING Monday, December 19, 2022 at 6:15 p.m.

As required by Massachusetts General Law Chapter 40, Section 56, the Town of Plympton Board of Selectmen will hold a Fiscal Year 2023 Property Tax Classification Hearing. Pursuant to Chapter 20 of the Acts of 2021, this meeting of the Plympton Board of Selectmen will be conducted via remote participation. Specific information and the general guidelines for remote participation by members of the public and/or parties with a right and/or requirement to attend this meeting can be found on the Town of Plympton's website: town.plympton.ma.us You may join the Zoom.us meeting via your computer via audio or both video and audio by copy and pasting the following link into your browser: https://us02web.zoom.us/j/84167349367. If you would prefer to attend via phone you may do so by dialing 1-929-205-6099. When it asks for the passcode enter 841 6734 9367 followed by #. It may ask for your personal passcode – if so, select # again. You will then be joined to the meeting. No in-person attendance of members of the public will be permitted, but every effort will be made to ensure that the public can adequately access the proceedings in real time, via technological means. In the event that we are unable to do so, despite best efforts, we will post on the Town of Plympton's website an audio or video recording, transcript, or other comprehensive record of proceedings as soon as possible after the meeting. The purpose of the public hearing is to consider the percentages of the FY2023 tax levy to be borne by each class of taxable real and personal property. The public hearing requires a vote by the Board of Selectmen for allocation of property tax classification. All persons interested in the determination may participate and be heard at the time and place stated above.
