### 1. Call to Order and Introductions

Chairperson Woelfel called the meeting to order at 10:00 A.M. and then read the meeting accessibility statement and the Title VI Notice of Protection Statement. Those in attendance then introduced themselves.

Chairperson Woelfel asked if there were any comments or changes regarding the minutes of the April 17, 2018 meeting. There were no comments or changes. The Old Colony MPO then endorsed the minutes of the April 17, 2018 Old Colony MPO Meeting.

## 4. Brockton Area Transit (BAT) Report

Vice Chairman Ray Ledoux provided a report on BAT activities:

- BAT held four public meetings regarding the potential fare increase. One was held in Stoughton, two were held at the BAT Centre, and one was held in Rockland.
- The fare increase will go into effect in July. The base fare will be increasing from \$1.25 to \$1.50.
- BAT is looking to increase parking rates at the Intermodal Centre from \$3 to \$4.
- BAT will be applying for funds to provide service in Stoughton. There may be a service change in Bridgewater and Plymouth.
- BAT is expecting the delivery of 12 new transit coaches in June.

Bill shine asked why funds are being cut for the Paratransit. Ray Ledoux explained that those funds are not being cut. Discussion followed.

## 5. Old Colony MPO Self-Certification Compliance Statement

- **Review and Potential Endorsement**

In order to provide due consideration, Charles Kilmer presented and discussed the Old Colony MPO Self-Certification Compliance Statement. The State and the MPO shall certify at least every 4 years that the metropolitan transportation planning process is being carried out in accordance with all applicable requirements including:

1. 23 U.S.C. 134, 49 U.S.C. 5303, and this subpart;
2. In nonattainment and maintenance areas, sections 174 and 176 (c) and (d) of the Clean Air Act, as amended (42 U.S.C. 7504, 7506 (c) and (d)) and 40 CFR part 93;
3. Title VI of the Civil Rights Act of 1964, as amended (42 U.S.C. 2000d-1) and 49 CFR part 21;
4. 49 U.S.C. 5332, prohibiting discrimination on the basis of race, color, creed, national origin, sex, or age in employment or business opportunity;
5. Section 1101(b) of the FAST Act (Pub. L. 114-357) and 49 CFR part 26 regarding the involvement of disadvantaged business enterprises in USDOT funded projects;
6. 23 CFR part 230, regarding the implementation of an equal employment opportunity program on Federal and Federal-aid highway construction contracts;
7. The provisions of the Americans with Disabilities Act of 1990 (42 U.S.C. 12101 et seq.) and 49 CFR parts 27, 37, and 38;
8. The Older Americans Act, as amended (42 U.S.C. 6101), prohibiting discrimination on the basis of age in programs or activities receiving Federal financial assistance;
9. Section 324 of title 23 U.S.C. regarding the prohibition of discrimination based on gender; and,
10. Section 504 of the Rehabilitation Act of 1973 (29 U.S.C. 794) and 49 CFR part 27 regarding discrimination against individuals with disabilities.

  - Task 4200 - Please define the acronym CRTP. Please provide more specificity with regard to potential projects (under “procedures”) and projects that you know will occur (under “products”).
  - Please check document for consistency in punctuation, capitalization, grammar and typos (e.g., page 20).
  - Please ensure that all relevant tasks are performed with input from MassDOT District 5.
- Old Colony Joint Transportation Committee (JTC) - The Old Colony JTC reviewed and approved the Draft FFY 2019 Old Colony UPWP.

- Page 3 - The narrative should include references to the FHWA required Transportation Asset Management Plan (TAMP) which is being developed by MassDOT to address pavement and bridge conditions on the NHS system.
- For the section on adopting MassDOT's safety performance measures (pages 8 - 10), please include the graphs containing statewide data in addition to the ones you currently have that contain regional data. Also, please delete the word "years" on page 9 following the descriptions of the targets for both the number and rate of fatalities.
- Page 10 - Please note that the Surface Transportation Program (STP) is now known as the Surface Transportation Block Grant Program (STBG) under the FAST Act.
- Please adjust the table numbering. It currently jumps from Table 4 on page 22 to Table 6 on page 25, without any Table 5.
