1. Call to Order and Introductions

Chairperson Noreen O'Toole called the meeting to order at 12:02 P.M. and then read the Meeting Accessibility Statement and the Title VI Notice of Protection Statement. Those present then introduced themselves.

2. Public Comments

There were no public comments.

3. Minutes of the May3, 2018 Meeting

Chairperson Noreen O'Toole asked if the members had reviewed the minutes of the May 3, 2018 Meeting. The members then voted to endorse the minutes of the May 3, 2018 Old Colony JTC Meeting.

4. Communications

Shawn Bailey reviewed the contents of the communications staff report. Included were letters of correspondence, as well as notices of workshops and conferences. They are as follows:

5. Reports

A. Brockton Area Regional Transit Authority (BAT)

Glenn Geiler stated that several of the new buses (12 buses, 2 hybrid) have arrived. BAT is in the process of replacing the crosswalks at the BAT Centre that cross Commercial Street. Pads are also being replaced on the bus platorms. BAT is currently applying for the Community Transit Grant Program, and they are planning to apply for replacement vans for Dial-A-BAT and Councils on Aging.

B. Greater Attleboro-Taunton Regional Transit Authority (GATRA)

Paul Chenard stated that the GATRA Fare Increase hearings would be commencing on June 25-27. GATRA is currently seeking a new bus garage location in the Plymouth area. GATRA will also be considering a possible Dial-A-Ride fare increase.

C. South Coast Rail Project

Paul Chenard stated that June 8, 2018 will the final day to submit comments on the Final Supplemental Environmental Impact Report (FSEIR). MassDOT will be reaching out to Phase 1 communities to discuss the project's schedule, upcoming activities, and next steps.

6. Old Business

A. FFY 2018-2022 Transportation Improvement Program (TIP) Implementation

Charles Kilmer highlighted project updates with regard to the FFY 2018-2022 TIP. They are as follows:

 - Construction Bid Opening Scheduled for 06/05/2018

- EASTON ROUTE 123 (DEPOT STREET) RECONSTRUCTION FROM NEWELL CIRCLE TO ROUTE 138 (607217)
 - Design Public Hearing Scheduled for 06/12/2018

7. New Business

A. Report of Nominating Committee and Election of Old Colony JTC Officers (2018-2019)

Dan Salvucci stated that the Nominating Committee has nominated Noreen O'Toole as the Chairperson of the JTC. Dan Salvucci has been nominated as the Vice Chairperson.

Chairperson Noreen O'Toole asked if there is a motion to approve the nominations. A motion was made and was seconded. The Old Colony JTC voted unanimously to elect Noreen O'Toole as Chairperson, and Dan Salvucci as Vice Chairperson.

B. Route 106 Corridor Study Update (Kingston, Plympton, Halifax, East Bridgewater, and West Bridgewater)

Ray Guarino provided an update on the Route 106 Corridor Study. This corridor study focuses on:

- Traffic volumes, including average daily traffic (24-hour) and peak hour turning movement data for thirty-two (32) Route 106 intersections
- Traffic speeds and heavy vehicle volumes along with truck operations and constraints
- Traffic congestion and delay including peak hour levels of service (LOS)
- Number and types of crashes and crash rates
- Transit operations
- Bicycle and pedestrian safety and accommodations, and access to transit
- Condition of the built environment including sidewalks, bicycle accommodations, Safe Routes to School, pavement conditions, pavement markings, traffic control devices and signage
- Land use and zoning and the potential impacts of this on traffic and transportation
- Consideration of the impact of transportation on public health

Dan Salvucci stated that there is a CVS being built on the corner of Spring Street and Route 18. Currently the traffic backs up to the fire station on Route 18. Dan Salvucci asked if it would make sense to make Spring Street a one way southbound. Ray Guarino stated that the Town has talked about making Spring Street a One Way. Discussion followed.

Charles Kilmer summarized the Environmental Notification Forms (ENFs), Environmental Impact Reports (EIRs), Notices of Project Changes (NPCs), and Certificates for projects within the OCPC region that are undergoing Massachusetts Environmental Policy Act (MEPA) Office review.

Projects Currently Under Review as of June 6, 2018

EEA #15854 - Previte's Marketplace Retail Development (Hanover) ENF)

Previte's Hanover, LLC, proposes the construction of a mixed-use development of up to approximately 25,290 square feet, consisting of a new Previte's Marketplace and general retail space on an approximately 3.45-acre site located on Columbia Road (Route 53/139) and Broadway in Hanover.

EEA #14346 - South Coast Rail Project (DSEIR)

The DSEIR analyzes new project elements associated with Phase 1, including improvements to track infrastructure on the Middleborough Secondary (an active freight line), Southern Triangle construction, a new station constructed in Middleborough at Pilgrim Junction, a new station in East Taunton, and modifications to previously studied stations at Freetown and Fall River.

EEA #4959 - Lakeshore Center (Bridgewater) (NPC)

Claremont Lakeside Bridgewater, LLC is proposing a material change in project scope, which consists of a proposed 40,000 retail office building, four proposed 3-story office buildings (totaling 94,001 s.f. and 951 parking space), a proposed office bank, and a proposed apartment complex at 1 Lakeshore Center in Bridgewater.

MEPA Certificates

EEA #15846 - Chestnut Street/ North Quincy Street Intersection Improvements (Abington and Brockton) (ENF)

MassDOT, in conjunction with Abington and Brockton, propose to reconstruct the intersection of Chestnut Street and Boundary Avenue and North, Quincy Street as a roundabout instead of the existing two-way stop. The purpose of the project is to improve safety and pedestrian crossings at the intersection while providing multi-modal transportation infrastructure that serves pedestrians, bicyclists, and motorists.

EEA #15850 - Dune Restoration between Crossovers 1 and 2 at Duxbury Beach (Duxbury) (ENF)

The Duxbury Beach Reservation, Inc., with advice from with the Woods Hole Group, proposes to design, permit, and construct a dune re-nourishment and restoration project between the first and second crossovers on Duxbury Beach. The proposed project will provide erosion control, buffer storm surge and protect critical habitat for wildlife.

C. Regional Concerns and Local Community Transportation Issues

Dan Salvucci stated that the MBTA Advisory Board meeting was yesterday. The MBTA is looking to increase ridership during the summer by running a \$10 ticket for the weekends. Commuter rail times will be extended into the night to accommodate late night workers.

Charles Kilmer stated that the Brockton Main Street signage and striping project is starting on June 11 and that parking will be prohibited between 7 PM and 5 AM for two weeks.

Rob May stated that Brockton has accepted a grant from MassDOT to complete the Project Needs Form (PNF) for the Main Street Two Way Project. The City will be developing a transportation model and coming up with three (3) alternatives.

Charles Kilmer stated that the Transportation Network Company's 2017 report of rideshare trips by community has been released.
