Charles Kilmer reported that the Stoughton – Tosca Drive/ Central/ Canton Street Project has been added to FFY 2022. With the completion of the 21-day public review and comment period, the Old Colony MPO is respectfully asked to review the public comments and consider endorsement of the Revised Draft FFY 2018-2022 TIP. The comments are as follows:

- **Old Colony Planning Council Board of Directors** – The Old Colony Planning Council Board of Directors reviewed and approved the Draft FFY 2018-2022 Old Colony TIP.
- **Old Colony Joint Transportation Committee (JTC)** – The Old Colony JTC reviewed and approved the Draft FFY 2018-2022 Old Colony TIP.
- **Marc Tisdelle, Stoughton Town Engineer** – Marc Tisdelle was hoping to see the Tosca Drive/Central Street intersection on the TIP.
- **Duxbury Board of Selectmen** – The Duxbury Board of Selectmen has voted unanimously in favor of expressing its continued support for the signalization of the Exit 10 ramps in Kingston and Duxbury, which is in each of your TIP Drafts currently out for public comment and review.
- **Nikki Tishler** – Comments provided are with regard to edits and corrections (project costs and project GHG analysis).
- **Annie Lemelin, CLF** – CLF hopes to see further investment in BAT. Further investment may be accomplished by flexing funding, which has been successful for other MPOs in the Commonwealth.
- **David Mohler, MassDOT Office of Transportation Planning** – In each fiscal year of the TIP there are highway funds available for programming. Please work with Highway Division District 5 and your municipal partners to identify or initiate projects to program these available funds. Please update the greenhouse gas emissions information for the 2019 Highway tab which reports an error on line 75 and on the 2018 Transit tab, line 6, which should be labeled as qualitative, until analysis can be completed.

Nick Giaquinto expressed support for the Brockton Projects in the TIP.

Glenn Geiler thanked MassDOT for all their support with the Transit Projects.

Pam Haznar stated that the Stoughton – Tosca Drive Project estimate is very preliminary. MPO should be cautious because there is potential for the cost to go up.

Marc Tisdelle expressed the Town of Stoughton's support for the Tosca Drive Project.

9. Proposed Critical Rural Freight Corridors (CRFCS) and Critical Urban Freight Corridors (CUFCS)

▪ Public Comments and Potential Endorsement

Ray Guarino discussed the proposed CRFCS and CUFCS.

The National Highway Freight Network is made up of four components:

1. **The Primary Highway Freight System (PHFS)**: The most critical highway portions of the U.S. freight transportation system. 41,518 centerline miles (37,436 Interstate centerline miles; 4,082 non-Interstate centerline miles)
2. **The Remaining portion of Interstate roads not included in the PHFS**: 9,511 Interstate centerline miles
3. **Critical Rural Freight Corridors (CRSCs)**: Public roads not in an urbanized area which provide access and connection to the PHFS and the Interstate with other important ports, public transportation facilities, or other intermodal freight facilities
4. **Critical Urban Freight Corridors (CUFCS)**: Public roads in urbanized areas which provide access and connection to the PHFS and the Interstate with other ports, public transportation facilities, or other intermodal transportation facilities

Massachusetts is allocated 150 miles of Critical Rural Freight Corridor (CRFC) mileage and 75 miles of Critical Urban Freight Corridor Mileage (CUFC). Old Colony is allocated 0.84 miles of CRFC and 3.44 miles of CUFC. This is based on Old Colony's centerline mileage as a percentage of Massachusetts as a whole.
