### 1. Call to Order and Introductions

Chairperson Noreen O'Toole called the meeting to order at 12:00 P.M. and then read the Meeting Accessibility Statement and the Title VI Notice of Protection Statement. Those present then introduced themselves.

Paul Chenard stated that GATRA is having some issues with service in the southern portion of Plymouth. GATRA is continuing to try and find resources in order to meet demand.

Charles Kilmer stated that there are no project updates since the last JTC Meeting.

## **7. New Business**

### **A. FFY 2018-2022 Transportation Improvement Program (TIP) Amendment 1**

Charles Kilmer reviewed the Draft FFY 2018-2022 Old Colony TIP Amendment 1 which was released by the Old Colony MPO for a 21-day public review and comment period on October 17, 2017.

The FFY 2018-2022 TIP Amendment 1 adds the Brockton Main Street Circulation Study (Federal Earmark MA-214) Funding for Design Project, and adds six (6) projects that were awarded as part of the 2017 Community Transit Grant Program.

## **C. Procedure for Establishment of Heavy Commercial Vehicle Exclusion Zones**

Bill McNulty provided a summary on the Procedure for Establishment of Heavy Commercial Vehicle Exclusion Zones.

Typical reasons for why a municipality may pursue a Heavy Commercial Vehicle Exclusion zone for a roadway in their community include:

1. Preservation of Infrastructure: Exiting heavy vehicle traffic is having a severe impact on the condition of pavement, culverts, and bridges on the roadway.
2. Safety: Excising roadway layout cannot safely accommodate heavy vehicles conflicting with other roadway users.
3. Quality of Life: Noise and pollution from heavy vehicles are creating an excessive burden on residents, particularly in densely developed residential areas and during hours of darkness.

Three primary warrants are considered by MassDOT when a municipality requests the establishment of a Heavy Commercial Vehicle Exclusions Zone on a municipal roadway. One or more of these conditions may be sufficient justification for the establishment of an HCVE.

1. An existing volume of heavy vehicles, typically 5 to 8 percent of total traffic, is reducing the utilization of a facility and is cause for substantial reduction in capacity and/or safety.
2. The condition of the pavement structure of the route to be excluded indicates that further repeated heavy wheel loads will lead to severe deterioration of the roadway.
3. Notwithstanding the foregoing, in certain instances where land is primarily residential in nature and a municipality has requested exclusion only during hours of darkness, specific night exclusion may be granted.

## **B. Staff Reviews on ENFs, EIRs, and NPCs**

Charles Kilmer summarized the Environmental Notification Forms (ENFs), Environmental Impact Reports (EIRs), Notices of Project Changes (NPCs), and Certificates for projects within the OCPC region that are undergoing Massachusetts Environmental Policy Act (MEPA) Office review.

## **Projects Currently Under Review**

## **EEA #15764 – Atlantic Link Project (ENF)**

The Project involves the installation of a subsea high-voltage direct-current (“HVdc”) transmission line to deliver clean energy from Atlantic Canada to Massachusetts, approximately 19 miles of which will traverse Massachusetts state waters. At landfall in Plymouth, the Project would include the construction of an underground HVdc cable extending approximately 2,375 feet, HVdc converter station, substation, and transmission line tap within currently undeveloped land owned by Entergy.

## **EEA #15769 – Gurnet Point Revetment (ENF)**

The purpose of the currently proposed project is to limit the amount of future erosion along the coastal bank. The proposed armor stone revetment will extend approximately 908 linear feet along the coastal bank. The crest of the revetment is proposed to be located at elevation +27.8 feet in order to minimize overtopping of the revetment by storm surge and waves which would further erode the bank.

### **C. Regional Concerns and Local Community Transportation Issues**

Charles Kilmer stated that at the October 25, 2017 OCPC Meeting, the Board of Directors elected Dan Salvucci to the Old Colony MPO to represent the communities with a population of 14,000+. This is his third term as an MPO Signatory. Chairperson O’Toole extended her congratulations to Dan Salvucci.

John Haines inquired about the Route 106 Study. Ray Guarino provided an update on the status of that Study.

Regarding the Route 106 Study, Tim Kochan asked what the Study boundaries are. Charles Kilmer stated that it is from Route 28 in West Bridgewater to Route 3A in Kingston. Tim Kochan stated that there are not any crash clusters east of Route 18. Charles Kilmer stated that it is necessary to look east all the way to the suburban and rural communities as there may be mobility and facility needs. The Study is not simply about safety only. It is about complete streets, looking at an areas need for sidewalks, traffic control, etc.
