7 p.m. Public Hearing

An Act authorizing the Silver Lake Regional School District to lease certain land for renewable energy purposes.

Notwithstanding section 16 of chapter 71 of the General Laws, or any other general or special law to the contrary, the Silver Lake Regional School District may lease the parking areas, the football stadium, and athletic fields owned by the district; provided that the lessee shall only construct and maintain renewable energy structures on or over the land and the lessee shall not use the land for any other purpose; provided, further, that any lease executed pursuant to this act shall contain such use restriction; and provided, further, that the district may grant easements over said land as necessary for the construction and maintenance of the renewable energy structures on the leased land. Notwithstanding any general or special law to the contrary, a lease executed pursuant to this act shall be for an initial period of up to 30 years, with the option to renew for up to an additional 30 years. The location and design of the renewable energy structures shall be subject to the approval of the Silver Lake Regional school committee after a public hearing.
