A letter from Zoning Officer was received regarding the earth removal requesting the current gravel permit be rescinded. The BOS would like better clarification of the earth removal operation and the farming maintenance at Mr. Randall's location. Mr. Traynor will speak to Legal Counsel to determine if a permit required to maintain bogs and if the current permit needs to be rescinded and a new one written or amend the current permit.
