## PLYMPTON BOARD OF SELECTMEN MINUTES April 26, 2010

Attendees: Joseph Freitas, Barry DeCristofano, and John Henry Meeting called to order at 7:00 PM

7:00 PM APPOINTMENT: Plympton Library Board of Trustees: Deb Dempsey, Chair, Debbie Baston, Library Director, Trustees, Patricia Detterman, and Susan Vetterlein were in attendance. Ms. Dempsey presented the Board with a letter stating that T.D. Bank North informed the Library Director that Elisabeth Dennett bequeathed approximately seventy thousand dollars (\$70,000) to the Plympton Public Library. The Trustees made a recommendation that 80% of the bequest be added to the existing Town of Plympton Public Library Endowment Fund and the remaining 20% be held in a separate line item gift account to be used for library purposes in accordance with the goals of the Long Range Plan.

**VOTED:** Motion made by Mr. Freitas to accept the bequest as recommended by the Plympton Library Board of Trustees. Second Mr. Henry. 3-0-0.

REPORTS: Mr. Henry reported that he spoke with Representative Thomas Calter. Mr. Calter informed him that the Senate and House voted to allocate \$811,000 in State Aide to the Town of Plympton.

Mr. Henry met with the Interim Police Chief on Friday, April 23, 2010 to sign contract and asked the Board to ratify the signed contract.

**VOTED:** Motion made by Mr. Freitas to ratify the singed Interim Police Chief's contract as part of the record. Second Mr. DeCristofano. 3-0-0.

7:15 PM APPOINTMENT: Finance Committee members: Max West, Lisa Hart, David Pecinovsky, and Tom Gillespie were present. Mr. DeCristofano greeted the committee and asked all present to refrain from any personal opinions and conflict. He reminded all present that the Town Meeting will be in two weeks and that the Town's residents will vote for the warrants that will be presented.

Also present were, Town Moderator, John Traynor and Town Clerk, Nancy Buter.

The Special Town Warrant and Annual Warrant Articles were reviewed and edited for final submission to Town Clerk and Finance Committee.

**VOTED:** Motion made by Mr. Henry that the Board of Selectmen should make their recommendations on all Warrant Articles with a vote count. Second Mr. Freitas. 3-0-0.

The Town Clerk stated that she must receive the Special Warrant Articles by Wednesday, April 28, 2010 at 5:00 PM.

The Finance Committee and Board agreed that the signed Special and Annual Warrant Articles and Cable T.V. Survey must be submitted by Thursday, April 29, 2010 in order to send out mailing to Town residents.
