MINUTES  
May 03, 2010

Attendees: Joseph Freitas, Barry DeCristofano, and John Henry  
Meeting called to order at 7:00 PM

Mr. DeCristofano opened the meeting stating that it would be a short meeting. There were no appointments scheduled and the Finance Committee invited the Board to their office to review the budget for the Town Meeting.

REPORTS:

Mr. Freitas received a call today at 4:00 PM from Mr. Edward Rose of Rocky Mountain Spring Water. Mr. Rose received a call from Governor Patrick requesting water due to the recent water main pipe break in Weston Massachusetts. Mr. Rose asked Mr. Freitas for permission to run extra trucks to the water site location for two days to accommodate the Governor's request. Mr. Freitas stated that he made an Executive decision, called the neighbor to inform her of the increase of truck activity and granted permission to Mr. Rose.

**VOTED:** Motion made by Mr. Freitas to permit Rocky Mountain Spring Water Company to increase truck activity for two days. Second Mr. Henry. 3-0-0

Mr. DeCristofano clarified a misprint on the Agenda. The May 10, 2010 Board of Selectmen Meeting will take place at the regular location, the Selectmen's room and will adjourn by 8:00 PM in order to allow the Planning Board use for their Zoning Hearings at 8:00 PM.

The State installed two signs on Route 106 and Route 58.

Mr. Henry reported that he met with Jeff Helm, the Town Insurance Broker to review the Police and Fire insurance policies.

**VOTED:** Motion made by Mr. Henry to increase the *aggregate?* amount from three million dollars to twenty five million dollars. Second Mr. DeCristofano. 3-0-0.

Mr. DeCristofano will edit the new Police Chief ad for publication for Police magazines and websites. He will report back to the Board.

Mr. Mark Gabriel stated he will volunteer to be on the Committee search for the new Police Chief. The Board agreed that with his experience the will be an asset to the Committee.

Mr. Freitas will contact Mr. John Walker to confirm his presence on the Committee.

Mr. Peterson, representing the Old Home Day Committee visited the meeting to inform the Board and Town residents of the upcoming fund raiser: "Rock and Line" Saturday, May, 15, 2010 at Reunion Farm. He will bring Insurance Certificate on May 10, 2010.

**VOTED:** Motion made by Mr. Freitas to recess meeting at 7: 20 PM to visit Finance Committee and reconvene to review Minutes and correspondence. Second Mr. Henry. 3-0-0.
