Meeting called to order at 7:00 PM

The Board signed the Town Building Committee appointment slips. Appointments were made on June 28, 2010.

7:15 APPOINTMENT: Finance Committee Members: Max West, David Pecinovsky, Cathryn Vroom, and Susan Ossoff were present. Mr. Henry reported that the budget is in better shape that the last fiscal year. Town Accountant transfer report was discussed:

VOTED: Motion made by Mr. Freitas to approve the year ending *Fiscal 2010 transfer requests that were submitted by Town Accountant, Barbara Gomez as written: Second Mr. Henry. 2-0-0.

Police Services \$550.00 to Police Expense line.

Building Department \$375.00 to Zoning Enforcement line.

Building Department \$234.70 to Building Clerical line.

Animal Inspector \$0.04 cents to Dog Officer line.

Veterans Expense \$7.50 to Veterans Benefits.

Police Service \$550.00 to Police Vehicle line. (see attachment)

VOTED: Motion made by Mr. West to approve the year ending Fiscal 2010 transfer requests that were submitted by Town Accountant, Barbara Gomez as written: Second Mr. Pecinovsky. 4-0-0.

There was discussion regarding the ambulance service line and fire service line of \$16,349.55 Mr. West reported that there is \$7,000.00 ear marked for unemployment payments and \$8,000.00 for Insurance payments for Police Department.

Mr. Freitas will research the Police motor cycle grant versus a payment plan and report back to the Board. Cost \$25,000.00 for motor cycle.

7:30 PM APPOINTMENT: James Mulcahy, Manager of Transfer Station. Discussion of three proposals from:

1. South Shore Disposal \$6,750.00 per month for Mixed paper. There were other options including Solid waste, and Co Mingled. Per ton was discussed.
2. SEMASS \$6,872.0 per month per ton.
3. Waste Management \$6,760.00 per month per ton.

Mr. Mulcahy stated that the price ranges are similar. Once the recycle program is implemented it will reduce tonnage factor. There will be a paper rebate refund/ Mr. Mulcahy will report back to Board his final report. He also reported that at a recent County meeting it was suggested to avoid rate locks in long term contracts due to the present economy and industry.
