Attendees: Joseph Freitas, Barry DeCristofano, and John Henry  
Meeting called to order at 7:15PM

Mr. Henry opened the meeting and reported that the Board had been in Executive Session Meetings since 6:00 PM with Interim Police Chief Harrison. Regular meeting began late.

**APPOINTMENT:** 7:15 PM Andy Joyce, Life Scout Troop 53 from Plympton, is working towards his Eagle Scout Certification. Andy has been working with Captain Cosato from the Plympton Fire Department developing an Eagle Project that will benefit the Fire Department and residents of Plympton. Andy presented the Draft Line Resource Identification Process (DRIP) project to the Board. This project has been approved by the Boy Scouts of America.

- Red reflective numerical identification signs will mark the already charted fire department water supply drafting sites throughout the town.
- Identification signs meet all town By-law requirements.
- Maps of the watering sites will have GPS coordinates and be distributed to surrounding mutual aid towns that assist Plympton.
- Brush clearing will be done when necessary.
- Andy will hold a fund raiser and sell wrist band bracelets to support the project. Any surplus funds will be given to the Plympton fire department.

The Selectmen thanked Andy Joyce for his pursuit for the very important project and gave their approval to proceed. There were a few advisements made to Andy by the Board.

- Contact Highway Surveyor, Tree Warden, and Conservation Commission regarding clearing of brush.
- As a courtesy to privately owned ponds, Andy accompanied by Captain Cosato visit home owner's and inform them of project.
