March 28, 2011

Present: John P. Henry, Joseph Freitas, and Barry DeCristofano.  
Meeting began 7:00 PM.

Mr. Freitas reported that the Board met in Executive Session since 4:30 PM.

Wage and Personnel Board, Chairman Chandler submitted a letter of support for the appointment of Mr. James A. Mustacaros to the Wage and Personnel Board. The appointment was made by Selectman DeCristofano and Finance Committee, Chairman West.

**VOTED:** Motion made by Mr. DeCristofano to appoint Mr. Mustacaros to the Wage and Personnel Board until June 30, 2014. Second Mr. Freitas. 3-0-0.
