

PLYMPTON BOARD OF SELECTMEN
MINUTES
October 17, 2011

Present: John P. Henry, Joseph Freitas, and Barry DeCristofano
Meeting began 7:10 PM

The Selectmen met in Executive Session at 6:30 PM with Town Accountant, Barbara Gomez, and Fire Chief Borsari to review ambulance bills.

Chief Borsari reviewed a new State requirement that all new recruits have a medical exam before they can attend the Fire Academy. Jordan Hospital Occupational Therapy quoted \$290.00 per person. \$2,030.00 is needed at this time.

The Board suggested that Chief Borsari inform the Finance Committee of State requirement. The Chief also discussed the repair of the 2003 Ford Explorer. A new engine is needed for the vehicle. The Board requested two more quote for repair work and contact Silver Lake Regional Body Shop.

Mr. Ken Thompson, 43 D Coordinator visited the meeting to discuss the Petition of NSTAR Eclectic Company – DPU 11-80 Exemption from Zoning By-Laws on Wednesday, October 19, 2011 at 7:00 PM. The Station off Brook Street and the Project. Mr. Thompson gave the Board a handout, with an overview, exemptions, etc. (see attached.) Much discussion over:
