

PLYMPTON BOARD OF SELECTMEN  
MINUTES  
June 18, 2012

Present: John Henry, Joseph Freitas, and Barry DeCristofano  
Regular meeting began at 7:00 PM

The Board met in an Executive Session Meeting at 6:45 PM to discuss Personnel matters.

Ms. Jacqueline Freitas, representing the Middleborough 4-H Fowl Play Poultry Club, along with young members, Kelsey and Jordan Reid visited the Board. They presented a grant, from Wal-Mart to three area local Food Pantries: Plympton Congregational Church, Halifax Congregational Church, and Our Lady of the Lake in Halifax. Each food pantry was given \$416.00

The Board of Selectmen reviewed the list of Committee/Commission appointments for FY 2013 and made their recommendations.
