Regular Meeting began at 6:30 PM

APPOINTMENTS: 6:30 PM Mr. Martin Mitchell of the Plympton Historical Commission presented the survey contract between the Town and Kathleen Kelly Broomer (Consultant.)

6:35 PM Fire Chief Borsari and Deputy Vautrinot presented the Board with the final bid award for the construction of the custom made pumper/tanker – mobile water supply vehicle with the C & S Specialty, Inc. of North Smithfield, Rhode Island.

Email request from Brad Prescott, Chair of the Town Building Needs Study Committee to appoint Mr. Jon Wilhelmsen. The Board requested that Mr. Pleau remain on the Committee until after a meeting with the Board and the Town Building Needs Study Committee in two weeks. The Board asked Mr. Pleau if he could write the RFP.

Mr. Freitas took a moment to read an informal, personal study/traffic log that he did.

Mr. Henry stated that Old Colony Planning Council will conduct a traffic study to include six streets in Town. The report will be compared Mr. Mulcahy's traffic study report prior the Sysco facility. Mr. Henry stated he contacted the Chief Executive Officers at Sysco, Lite Control and Lawrence Ready Mix regarding trucks traversing side streets. The CEO of Lite Control confirmed that the last of their Cape Cod Express trucks are nearly done with their recent move from Hanson to their Plympton facility. The CEO at Lawrence informed Mr. Henry that a large project at Bridgewater State College is near completion which will reduce any truck traffic. The CEO at Sysco assured Mr. Henry will take care of traffic disturbances.
