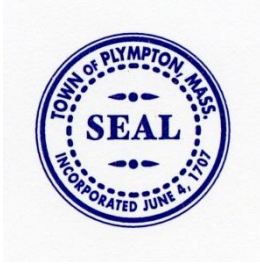

March 2, 2015

Selectmen, Chair Mark Russo (MR), Colleen Thompson (CT) and John Henry (JH) and Town Coordinator Dale Pleau present.

Chairman Russo called the meeting to order at 7:05 pm.

Mr. Russo opened the meeting with a statement of ground rules and a moment of silence.

Silver Lake Regional School District:

- Mr. Russo explained the new Silver lake School Committee, Budget/Revenue sub-committee
- Mr. Henry noted that the Silver Lake School Committee vote of January 8th to spend \$619,000 from the excess and deficiency account was rescinded by the School Committee on the advice of their counsel.

Cable PEG access:

- Mr. Russo noted he had discussions with Town Counsel regarding joining the Halifax/Carver and potentially Plympton PEG access studio. He also noted that he sat in on the Halifax-Carver Studio Board of Directors meeting.

Town Vacancies:

- The board noted that there are several vacancies on town boards and committees. The processes of getting an article on the Town Meeting Warrant and running for office were explained.

South Shore Community Action Counsel:

- Mr. Russo explained the mission of the Counsel. There was a general discussion. Ms. Thompson stated it would be nice to give them a wider audience to let residents know of their services.

Town House Weather Closing:

- Mr. Russo initiated a discussion on how best to notify employees.

Dennett field sprinklers:

- Art Morin has volunteered to turn the irrigation system on when needed.

- Discussion on holding a public hearing and Town Counsel review of the revised solar by-law. Mr. Pleau said he will take care of both matters. The Board of Selectmen unanimously commended the By-law Review Committee for all their hard work on revising the bylaw.
