Mr. Henry opened the meeting and reported he had attended the Finance Committee Meeting.

APPOINTMENT:

7:05 PM Ms. Karen Foye and several Brownies of Troop 75462 attended the meeting. Ms. Foye gave an update of the community garden project. The desired area for the garden is the Town owned strip of land between the Fire Department and Library buildings. The garden will be approximately 20X24' A portion of the garden bounty will be donated to area food pantries. The community is welcome to add to the garden. Donations for supplies will be welcomed.

VOTED: Motion made by Mr. Russo to approve Troop 75462 community garden and location. Second Mr. Henry. 2/0

At 7:20 PM this concluded the Brown Troop 75462 update with Board.

TOWN COORDINATOR UPDATES:

Mr. Pleau presented the draft Warrant, Special Town Meeting Warrant and Annual Town Meeting Warrant for review and discussion:

- 30B sale of land specifics need to be reviewed- Contact Town Counsel for "wording"
- ADA and Alarm bids will be advertised for bids
- Meeting requested with Town Accountant, Selectmen, Finance Committee, Town Moderator and Accountant to review Warrant prior Town Meeting
- Architectural and Engineer Public Safety building two possibly third site, cost \$9,500.00 each to determine suitability and build ability

The Board of Selectmen signed the contract for Robert's Roofing and Construction.

During this discussion period, Mr. Henry reported there is one half million dollars in the Capital Stabilization Fund and same coming. He hopes there will not be a real estate tax increase this year. Mr. Russo recommended that the Public Safety building project be taken from this year's Town Warrant for the following reasons:

- The cost for A and E fees is estimated at \$620,000
- Site location has not been determined
- There is no Committee to administer and coordinate work load

Mr. Henry agreed with Mr. Russo and the Article for Architectural and Engineer – Public Safety building be removed from this year's Warrant.

Mr. Henry relayed bits of conversation with the Finance Committee: The Committee would like a comparison dollar amount for tile versus carpet for Town House foyer and hallway. Halifax has had their Town Meeting. They will reduce dollar amount to Silver Lake. Make quarterly payments of \$26,000 to Kingston. Plympton Finance Committee has spoken with Kingston for their legal opinion and contract for Silver Lake payments.

This concluded the Warrant discussion.
