8:00 PM Finance Committee: Members present: Susan Ossoff, Chair, Max West, Mark Gabriel, Lisa Hart and Marilyn Browne. Ms. Ossoff presented the (CIPC) Capital Improvement Plan Committee project Requests FY15 Budget Cycle to the Board. The list reflected Town Department's requests for the next five years. Some of the dollar amounts are estimates, others are more accurate figures.

Mr. Henry asked if the proposed Police and Fire Station were part of the CIPC plan. There was much discussion to include this in the Special FY15 or wait and include in the FY16 budget. Ms. Ossoff will review future CIPC Department request and report back to Board with FY15 shortfall amounts.

Also, discussed was the 2% Wage and Personnel increase for Town Employees. There was some debate over the increase of salaries; W&P does not enforce raises, only recommends any increases.

Mr. Henry presented a list of the top 20-25 salaries of Town Employees. He reported other Towns list these type salaries on Town websites and thought Plympton should as well.

The topic of the roof repair became an issue as Finance Committee was unaware of the plight of the water damages that needed to be paid, possibly out of the Capital Stabilization Fund or the Reserve fund. Approximate cap cost \$18,600.00 Mr. Pleau is soliciting bids for the repair to roof.

The Finance Committee and Board of Selectmen will meet within the next few weeks for further discussions.
