The Town Building Needs Study Committee was present and Barry DeCristofano led off with a brief explanation and introduction. Reinhardt presented 5 possible solutions involving the types of buildings and their locations.

- Mr. Pleau explained to the Board that the Green Communities Grant is in the process of being written and that the bulk of the grant will go to lighting improvements at Dennett School and the Highway building. Mr. Henry stated that these departments should be notified of the estimated savings and to reduce their FY 2016 budgets accordingly.
- Drafts were presented for a medical marijuana bylaw and public gathering bylaw. The board will review these and make recommendations for the annual town warrant.
- The sale of the surplus GMC fire truck is proceeding and the truck should be picked up in the near future.

Mr. Henry states that the Silver Lake Regional School District has released their FY 2015 budget showing an increase of 6.11% over FY 14. He also note that under the new State formula Plympton's share will increase fro 10.9% to 11.4%.
