We will request updated total taxable property values and new growth figures from the Assessors to assist in projecting an estimated tax rate and percentage increase in spending for Town Meeting. Figures adjusted to reflect most recent information.

Committee and Accountant reviewed all lines in the proposed budget. Figures adjusted to reflect most current information. Total figure of \$9,848,302 is a 1% increase over last year's budget. It should be remembered that Special Education and Vocational Education budgets are down significantly but are not expected to continue in the future.
