The Board met in Executive Session to discuss contracts for FY 2014: Police Chief, Fire Chief and any solar project contracts.

Building Commissioner, Tom Millias was asked to come to the meeting to discuss any building permits or questions in regard to the proposed boardwalk at the Churchill Park site.
