Present: Selectmen; Mark Russo, Christine Joy, Colleen Thompson & Town Coordinator Dale Pleau Meeting called to order at 6:00 pm.

Mr. Russo opened the meeting with a moment of silence.

Regionalization and Transportaion Costs:

• Ways to save money on projects in town. The Kingston selectmen's office had indicated they had some interest in projects between towns. Mr. Russo will generate a letter and send to the surrounding towns of Carver & Kingston.

District Transportation Costs:

• Discussion on the possibility of having a waiver or elimination of the out of district transportation cost. The current expense is approximately 13K. Mrs. Joy will reach out to State Representative Tom Calter if this is at all possible. This could also be a project for the regionalization discussed between towns.

Town Policy:

- Creating a new personnel & hiring manual for the town. This would be something new for the
 town. There would be a vote to elect a Human Resource Manager. The selectmen will be
 adopting a policy each week until the manual is complete. Each article to be adopted will
 posted to the towns website for 10 days for any comments or concerns that may need to be
 addressed.
- Vote to adopt the "Addition and Amendment of a policies", Mr. Russo, Second, Ms. Thompson, 3/0.

• Elsie Murgida, a resident of Plympton, has concerns with the upkeep of the corner of Forest Street & Oak Streets. The corner is overgrown and she has concerns of the safety of busses and children.
