- Excessive noise on Brook Street from the Sysco trucks at night has nearby residents concerned. The matter was addressed to Sysco. The President of Sysco, Chuck Fraser, has responded with a letter stating that new white noise alarms have been installed in the trucks. This should reduce the noise and that the alarms meet the OSHA requirements.
- Fin Com and BOS received a request via email, who was identified as John Henry, to have the meetings of the Finance Committee video recorded and broadcast. Fin Com has stated they do not have a problem with this. They presently meet in the back office of the Town Clerk's office. The space is small but the public is welcome and always has been. Mr. Henry referred to the space as "a closet". The Finance Committee is not willing to move unless they are given a permanent space in the Town House. This space works for them and documents and computer are secured. The BOS are also okay with the current space provided and do not believe a move is necessary. The meetings are posted and are open meetings. The public is always welcome. There will be no action in moving the meeting space or having the meetings recorded at this time.
