Updates & Discussions:

- Fire Chief Warren Borsari spoke regarding the current staffing issues for Fire/EMS and risks to the town. One of the major issues is the current pay rate offered. John Traynor and Chief Borsari presented a proposal to increase the wage for paramedics with comparisons.
- Discussions regarding the Assistant Assessor position will be on the BOS agenda for 1/30/17.
- Fin Com members, Susan Ossoff, Lisa Hart, Marilyn Browne, Nathaniel Sides and Eric Hart were present to discuss the upcoming Budget Process. This will include the Financial Planning materials prepared with The Collins Group. Fin Com has issued Capital Request forms to departments. Public Records Requests issues and 3 software programs available was discussed. The software would help in streamlining the process of the requests and estimated at \$1,800 per program with a \$400 yearly maintenance fee. IT grants are becoming available March 1, 2017. The Article should be written as back-up for the Town Meeting. Currently the Capital Improvement Planning Committee is the same as the Finance Committee. Members of FinCom would like to change the current bylaw and split the two committees. FinCom will submit a draft of the bylaw change by email to Town Counsel.
