# Plympton Town House New Meeting Room

### 6:00 Selectman Chair John Traynor called the Open Session to order.

Present: Board of Selectmen (BOS), Christine Joy (CJ), John Traynor & Mark Russo (MR). Town Administrator (TA), Elizabeth Dennehy. Selectmen's Assistant, Briggette Martins.

### **Updates & Discussions**:

• BOS voted to accept the lowest qualified bid received from Lindey Construction for the Bandstand Restoration Project (18-TGB-1).

Vote: MR made motion per the recommendation of the Historical Society to approve the bid from Lindey Construction for the restoration of the Bandstand. Seconded, CJ. 3/0.

• Adoption of Electioneering Policy MGL Chapter 54, Section 65 as requested by the Town Clerk.

Vote: MR made motion to adopt and sign Electioneering Local Policy MGL Chapter 54 Section 65. Seconded, CJ. 3/0.

Atwood Irrevocable Trust and the Town of Plympton Compliance Agreement

Vote: MR made motion to approve and sign the Compliance Agreement for the purchase of the Atwood property on Prospect Road. Seconded, CJ. 3/0.

• Atwood Irrevocable Trust and the Town of Plympton Ouitclaim Deed

Vote: MR made motion to approve and sign the Quitclaim Deed for the purchase of the Atwood property on Prospect Road. Seconded, CJ. 3/0.

• Discussion of Town Counsels recommendation to authorize the Town Administrator to sign all remaining necessary documents to complete the transaction including a settlement statement for the purchase of the Atwood Property on Prospect Road.

Vote: MR made motion to approve Town Administrator Elizabeth Dennehy, per recommendation of Town Counsel, to sign remaining necessary documents to complete the transaction for the purchase of the Atwood Property. Seconded, CJ. 3/0.

- Animal Control Officer Griffin Webb and BOS discussed the Town ACO bylaws, enforcement process, fines, and the adoption of a potential leash law. The current bylaws need revision for ease of use and understanding by residents and the enforcement officer. MR and ACO Griffin Webb will review the current ACO bylaws and submit recommendations to the Bylaw Review Committee. The ACO discussed the recent dog incident on 10/15/18 and will order the dog Mandy be muzzled for 14 days. The Board requested the ACO conduct an investigation and submit his findings and recommendations to the Board by their next meeting on 11/5/18.
- Rich Goulart of Area 58 discussed the audio system and option for meetings to stream live.
- Liz and BOS discussed implementing a form and procedure process for Procurement.
- BOS voted to rescind the 10/15/18 Planning Board Appointment of Irving R. Butler

Vote: CJ made motion to rescind the 10/15/18 appoint Irving R. Butler to the Planning Board. Seconded, JT. 3/0.
