### **Updates & Discussions:**

- Elizabeth Dennehy, the new Town Administrator visited the Town House and local landmark areas in town. Repairs to the bathroom in the Administrators office will begin Friday, December 1<sup>st</sup>. BOS approved the purchase of a new laptop for use by the Town Administrator.
- Electrical Aggregation decision was made to commit to an electrical aggregation plan. The residents will have the option to Opt-Out. New rates take effect January 1, 2018.
- BOS reviewed the Green Community application. Selectmen's Assistant will pull the report for electric bills and email Fire, Police & Highway departments for fuel reports.
- BOS received a letter of support from Halifax BOS, Charlie Seelig regarding the Efficiency and Regionalization Grant.
- Ocker's finished the wiring for the White Board in the Large Meeting Room.
- Community Preservation Committee will be meeting on 11/21/17 to discuss the renovation on the Old Town House.
- Assistant Assessor employment opportunity at the Town House is posted on the website, Town House, and MAA. Resume's will be sent to the BOS Assistant and forwarded to the Assessor's Office. Deb Stuart has fully resigned as of 11/17/17. The Assessor's will meet with the BOS on 11/27 to discuss and set the tax rate.
