Present: Selectmen Christine Joy (CJ), John Traynor (JT) & Mark Russo(MR) By rollcall vote the BOS adjourned to Executive Session (MGL 30a §21) to discuss Purpose 2

6:00 Selectman Chair Christine Joy called the Open Session to order.

Present: Board of Selectmen (BOS), Christine Joy (CJ), John Traynor, & Mark Russo (MR). Town Administrator (TA), Elizabeth Dennehy (ED). Selectmen's Assistant, Briggette Martins.

6:00 Tax Classification Public Hearing Opened:

• The Board of Assessors and the Assistant Assessors discussed whether the FY17 tax rate for Residential, Open Space, Commercial, and Industrial and Personal Property Classes should be a Single or Split Tax Rate. The Dept of Revenue requires the vote by the BOS prior to setting the FY17 tax rate. The vote would determine the percentage of tax levy to each class of Real Property and Personal Property owners. The Board of Assessors provided data relevant to the Fiscal effects of available alternatives. The Selectmen are required to vote also on the small commercial exemption. This vote would reduce property tax on small businesses and shift the tax onto commercial and industrial properties. The Board of Assessors will submit the recap sheet to the DOR for approval of the tax rate.

Vote: CJ made a motion to approve the BOA recommendation to keep a Single Tax Rate for Residential, Open Space, Commercial, Industrial, and Personal Property Tax Classes and for the BOA to submit the requested form to DOR. Second JT, 3/0.

Vote: CJ made motion to not adopt the small commercial exemption, residential exemption and commercial space exemption. Second JT. 3/0.

Vote: CJ made motion to close Open Public Hearing. Second JT, 3/0.
