• Dave DeBaie, Traffic Engineer with Stantes Consulting, is under contract with Mass DOT 64319 to help design and prepare safety improvement documents for selected rural roadways in Plympton and surrounding towns. Jim Mulcahy, Plympton Highway Superintendent was present for the presentation. Mr. DeBaie discussed with the BOS the improvement plan for signing replacement, pavement markings, guardrail replacement and other improvements. This work would be done to six roads in town, Main Street, Palmer Road, County Road, Center Street, Parsonage Road and Mayflower Road. The project is in the planning stages. The final plan will be submitted in April 2017 and project completed by fall of 2017.
