**Appointments:**

CJ introduced Municipal Resources, Inc. (MRI) report. MR read the rules for the meeting. JT gave the names of consulting agencies the BOS had to choose from and why MRI was hired for the study. MRI was hired in September 2017 and the study is a 107-page report and will be available on the Town's website and in the office for review.

**CJ made motion to recess for 5 minutes. Second JT, 3/0.**

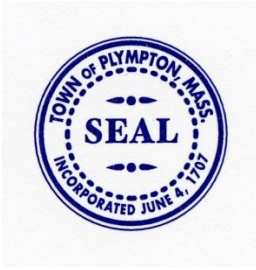
**CJ called meeting to order**
