- Public Safety Building Committee Presentation
  - O Jeff Shaw, designer architect at Context Architecture Inc. (previously Donham & Sweeney) and Dan Pallotta of P3 Consulting presented a campus site plan. This included a diagram showing the layout of the property and floor plan of the building for the proposed Police Station and a Project Appropriation Budget. The projected cost is estimated at \$2,971,000. The Warrant Article submitted is for \$3M. Tour dates of police station are 4/8/17 and 4/12/17 to show residents the current condition of the Police Station, view the proposed plans submitted, and answer any questions.
- FinCom members Susan Ossoff, Lisa Hart, Marilyn Browne, Eric Hart, and Nathaniel Sides were present to discuss and review the FY2018 Budget Draft.
