# 6:00 Selectman Ms. Thompson called the Open Session to order.

Present: Selectmen Colleen Thompson (CJ) & Christine Joy (CJ). Town Coordinator Dale Pleau (DP). Selectmen's Assistant Briggette Martins. John Traynor was absent.

## Updates & Discussions:

- Plymouth County FY18 Budget
  - Plymouth County Treasurer Thomas O'Brien, County Commissioner Sandra Wright, and Plymouth County Administrator Frank Basler attended the meeting to discuss the Plymouth County Operating Budget for FY18. They presented the BOS a print out of the approved revenues, budget and summary voted on by the Plymouth County Commissioners on 4/6/17.
- Jon Wilhelmsen, member of the Dennett School Committee, discussed the present water issues at the Dennett Elementary School. A recent study from the Department of Environmental Protection showed high levels of lead. The testing was performed in August and the school was closed all simmer, which may have contributed to the elevated levels. A quote of 130k was received to repair and install a treatment design to the existing system and well. The Committee is waiting for the vote at Town Meeting for the funding of the water treatment design and has been in discussions with the DEP to avoid any penalties for failure to address the issue. If the article passes a Request for Proposal (RFP) will be written and submitted for posting.
- Letter from KP Law confirming the purchase of the property for the Police Building has been completed.
- Frank Bush ACO has filed formal reports for the two dog complaints:
  - 4/15/17 Ring Road
  - o 4/21/17 Popes Farm
- BOS discussed the estimate received to have Town Counsel review the town bylaws.
