The Town of Plympton is pleased to announce that **Public Power, LLC** has been selected as the supplier for its Community Choice Power Supply Program ("Program"). Public Power will provide electric power supply for all consumers participating in Plympton's Program. This notice is intended to tell you about this Program for electric power supply. In accordance with state law, it also informs you of your rights and options if you choose not to participate in the Program.

YOU WILL NOT NOTICE ANY CHANGE IN YOUR ELECTRICITY SERVICE. You will see Public Power printed under the "Supplier Services" section of your monthly bill. You will continue to receive one bill from Eversource. You will continue to send your payments to Eversource for processing. Eversource will continue to respond to emergencies, read meters and maintain the distribution and transmission lines. Reliability and quality of service will remain the same. Furthermore, you will continue to have all existing consumer rights and protections.

IF YOU DO NOT WISH TO PARTICIPATE you must OPT-OUT at www.colonialpowergroup.com/plympton/, click the OPT-OUT button and follow the instructions specified OR call Public Power at (800) 830-2944.

TO CHOOSE A GREENER PRODUCT WITH A HIGHER PERCENTAGE OF RENEWABLE ENERGY you may call Public Power at (800) 830-2944 and ask to be enrolled in Plympton's Optional Green Product. Plympton's Optional Green Product provides 100% renewable energy, including 77% National Wind Renewable Energy Certificates (RECs). This product is being offered at \$0.11158 per kWh for 30 months (July 2018 to January 2021).
