ATTENTION DOG OWNERS
DOG LICENSES WILL BE AVAILABLE JANUARY 1st

*According to the Town of Plympton Municipal Bylaws Article XXI, ALL dogs over the age of 6 months in Plympton must be licensed between January 1st and December 31st annually ("License Period"). A **current rabies certificate IS REQUIRED to receive a license**. ***Please note that a "License Late Fee" of twenty five dollars (\$25.00/household) in addition to the license fee will be imposed after March 31st following to December 31st for any overdue license.** After July 1st violators shall be subject to a Non-Criminal Citation (21-D) with a fine of one hundred dollars (\$100.00) to be paid to the Town of Plympton, and the owner or keeper of the dog will be required to immediately procure the current license and tag.*

Payment must be made either by check or money order made out to the Town of Plympton in the amount applicable below.

LICENSES MAY BE OBTAINED FROM THE TOWN CLERK IN EITHER OF 4 WAYS:

1. **TOWN CLERK'S OFFICE** with *current rabies certificate and payment during regular office hours Monday through Thursday between 9 a.m. and 2 p.m, and Monday evenings 5 p.m. and 7 p.m.
2. **MAIL** your application, *current rabies certificate for Town Clerk records, and payment ****including a self-addressed stamped envelope** to: Town of Plympton, Attn: Town Clerk, 5 Palmer Road, Plympton, MA 02367. Your tag and copy of printed license including receipt details for your records will be mailed to you upon receipt.
3. **DROP** your application in the drop box, located outside of the Town House door, with *current rabies certificate for Town Clerk records, and payment ****including a self-addressed stamped envelope**. Your tag and copy of printed license including receipt details for your records will be mailed to you upon receipt.
4. **UNIBANK QUICKPAY**: See the Town Website homepage for a link under Town Resources/Pay Bills Online/Town Clerk/Dog Licenses for credit card or electronic payments.

**If you have a CURRENT rabies certificate on file with us from previous years, you do not have to provide another copy
(Most adult canine rabies certificates are valid for 3 years)*
